- 1. **Contest Dates and Timelines:** The Contest will have two (2) rounds: Round One online entry forms; and Round Two finalist presentations. Finalist presentations will take place onsite at CES® Unveiled Amsterdam on October 15, 2024 at the Beurs van Berlage Amsterdam Conference Centre (the "Event").
 - a. **Round One Entry Period:** The entry period for Round One begins 12:01AM CEST (Central European Summer Time) on June 11, 2024 and ends 11:59PM CEST September 20, 2024. Judges will pick the top eight (8) to ten (10) finalists to compete in Round Two.
 - b. **Round Two Timeline:** One (1) winner will be selected by a panel of five (5) judges onsite during the Event. The winners will be announced on the same day by 9:00 PM CEST.
- 2. Contest Sponsor and Prize Provider: Consumer Technology Association, 1919 S. Eads St., Arlington, Virginia 22202, USA.
- 3. **Eligibility:** The contest is only open to startups registered to attend the Event. Employees, contractors, and directors, of CTA, its subsidiaries, sales representatives, advertising, promotion and all other service agencies involved with design, execution or fulfillment of this Contest, and members of the immediate families (defined for these purposes as parents, children, siblings, domestic partner and spouse) or households (whether related or not) of any of the above are NOT eligible to participate. Entries deemed by CTA in their sole discretion to be immoral, obscene, indecent, profane or not in keeping with the CTA's image will be disqualified. CTA reserves the right in its sole discretion to disqualify any entry at any time which, in the CTA's opinion, endangers the safety or wellbeing of any person, or fails to comply with these Official Rules. CTA decisions are final and binding.

4. Requirements:

- a. Company Criteria
 - Contestants must be registered attendees for CES Unveiled Amsterdam 2024.
 - Contestants must be eligible to exhibit in Eureka Park® at CES 2025, including by meeting the below criteria:
 - Contestants must have been founded between 2019-2024 and operate with the purpose of building or marketing software or hardware products.
 - The technology displayed must be applicable to the consumer technology space.
 - Contestants must show a technology that can be realized commercially within three (3) years but is not currently available to consumers. An exception will be granted to software/online services currently available to consumers with public launch dates no more than nine (9) months prior to CES 2025.
 - o If the Contestant submits a product currently available to consumers, the product cannot have been shipped or been on the market prior to January 1, 2024.
 - Technology must be demonstrated as a prototype or software mockup at CES (no paper/concepts).
 Companies must show finished goods under their own brand names rather than as an OEM/ODM.
 - The product or service must be innovative with the potential to make a profound impact on the market.
 - The company must have no known intellectual property conflicts.
- b. Language: English
- c. *Exhibit Space Contract Agreement*: If selected as a winner and eligible for Eureka Park, you must agree to sign and return a CES 2025 Exhibit Space Contract with CTA to reserve your booth space in the Eureka Park exhibit area at CES.

5. How to Enter/Submission Details:

a. Round One Submission Criteria ("Entry"): To enter, Contestants must submit their company's product for consideration via the online form found at https://cea.formstack.com/forms/pitch_battle_at_ces_unveiled_in_amsterdam during the Round One Entry Period. Only one (1) entry form may be completed per product. Contestants must confirm that their company meets the eligibility and entry requirements, and that representative(s) would be available to participate in the Event on October 15, 2024 if selected as a finalist for Round Two. The judging panel will consist of five (5)

individuals having knowledge of the tech industry and business funding (which could include, for example: a representative from EIC; an engineer from an established company or innovation and research facility; a CVC investing partner; and two venture capital investors).

- Pitch Slide Deck: Contestants must provide, via Google Drive or Dropbox link, a pitch slide deck not more than five (5) slides, excluding a title slide.
- Pitch Video Run Time: In lieu of a pitch slide deck, contestants may provide a link to a business/product pitch video no more than one (1) minute long.
- Slide deck must be in English.
- b. Round Two Finalist Presentation Criteria ("Presentation"):
 - Must be able to participate in the Event on October 15, 2024.
 - Each startup will have three (3) minutes to present their company's product and two (2) minutes for questions and answers from the voting attendees.
 - Pitch video and slide deck may be used, provided the entire presentation remains within the three (3)-minute timeframe.
 - Presentation must be in English.
- c. Copyright: All materials submitted during Round One Entry and materials used in Round Two Presentation must be of your own original work and property and may not contain any commercial copyrighted images. By entering the Contest, you represent and warrant that (a) your Entry and Presentation is your original work and that you own all rights, including copyright rights; (b) Your Entry and Presentation do not infringe the intellectual property, privacy or publicity rights or any other legal or moral rights of any third party; (c) Your Entry and Presentation do not contain any defamatory, libelous, indecent, illegal or obscene material; and (d) you have obtained permission from each person whose name, image, or likeness (collectively, "Likeness") is included in your Entry and/or Presentation, such person(s) have granted you all necessary rights to use their Likeness as described in these Official Rules, and you can make written copies of such permissions available to CTA upon request. (If the Likeness of a minor is included in your Entry or Presentation, such grant of rights must include written permission from the minor's parent or legal guardian authorizing the use of the minor's Likeness.)
- 6. **Round One Finalist Selection and Notification:** The judging panel will select eight (8) to ten (10) finalists to compete in Round Two from eligible Round One submissions, dependent on the number of eligible entries received. Round One submissions will be judged based on the following criteria:
 - a. Meeting Entry Requirements outlined in these Official Rules;
 - b. The product's application of technology for positive societal impact;
 - c. Judges will score each product out of 5 for each of the following categories:
 - i. Uniqueness: Innovative Marketing Opportunity
 - ii. Problem & Solution: Strength of Business Concept
 - iii. Overall Feel: Attractiveness to Learn More

Designation as a finalist is subject to proof of compliance with Official Rules, maintaining compliance with these Official Rules, and approval by CTA. Finalists moving on to Round Two will be notified via email by October 1, 2024.

Press Release: CTA will promote this Contest on social media and have the right to mention finalists as part of the Contest. CTA will also create a press release on the Contest including the Contest winner. If selected as a winner, you agree to be publicized in this press release.

7. **Round Two Winner Selection:** Finalists will present their products during the Event on October 15, 2024. The same judges as Round One will evaluate the expanded presentations for the submitted products, unless CTA at its discretion must replace a judge with equal or similar qualifications due to unforeseen circumstances. The winning startup will be selected based on the judges' votes for the product's ability to meet the following qualifications: 1) The product's application of technology for positive societal impact; 2) Uniqueness; 3) Problem and Solution; 4) Overall Feel. Winners will be announced the same day during the Event. Any ties in the Judge scores will be resolved by a vote amongst the judges and representatives of CTA using the Round Two criteria.

Odds of winning depend on the number of eligible startups presenting. Contestants may be from the Netherlands or other nearby European countries and the winner will be determined out of all entries of the countries combined. Based on the demographic and number of entries, no winner from the Netherlands may be selected. Designation as a prize winner is subject to proof of compliance with Official Rules, maintaining compliance with these Official Rules and approval by CTA. As a condition of winning the prize, winners will be required to supply contact information including, but not limited to name,

address, phone number, email address, and LinkedIn Profile. Personal information will be used solely to facilitate the Contest and distribute prizes and will not be used for marketing purposes. Once notified, winners must complete a CES 2025 Exhibit Space Contract which must be signed and returned to CTA within 20 days of CTA's initial sales contract. Failure to timely sign and return this Exhibit Space Contract may result in the applicable winner's disqualification, forfeiture of all interest in prizes, and the selection of a substitute winner. Total maximum ARV of all prizes: \$3,500 USD.

Prizes are not transferable. No substitutions, except that CTA reserves the right to substitute a prize of equal or greater value. All prizes will be awarded provided they are properly claimed in accordance with these Official Rules and a sufficient number of eligible entries are received. If a prize winner is 18 but deemed a minor in his/her state of residence, the prize will be awarded on behalf of the minor to his/her parent or legal guardian, who must comply with the prize claim requirements. The Winner is responsible for any applicable taxes on the value of the prize.
